



## **DENTAL CANDIDATE INFORMATION FOR ADEX DENTAL EXAMINATIONS ADMINISTERED BY CDCA-WREB-CITA**

**The Dental College of Georgia at Augusta University reserves the right to cancel or postpone hosting the 2023 CDCA-WREB-CITA/ADEX dental licensure examination at any time due to the COVID-19 pandemic.**

The intent of the information contained within this document is to assist the dental licensure board candidate with taking the American Board of Dental Examiners (ADEX) Dental Examination administered by the Commission on Dental Competency Assessments-Western Regional Examining Board-Council of Interstate Testing Agencies (CDCA-WREB-CITA) and hosted by The Dental College of Georgia (DCG) at Augusta University. This document provides information about the 2023 CDCA-WREB-CITA/ADEX dental licensure examination that you will be taking at the Dental College of Georgia. The document also explains how the Dental College of Georgia staff will assist you in making this a successful experience. **Candidates should read this entire document before calling DCG with questions since it contains pertinent information.**

**DISCLAIMER: Augusta University is NOT affiliated with CDCA-WREB-CITA. Any procedural questions concerning this examination should be directed to the CDCA-WREB-CITA officials.**

### **ACKNOWLEDGMENT OF THE DENTAL COLLEGE OF GEORGIA'S LIMITED ROLE**

Prior to the administration of the examination, The Dental College of Georgia at Augusta University will require and collect fully executed Release Forms signed by all candidates and patients, acknowledging the University's limited role in the administration of the examination and releasing the University from any liability in connection with such examination. All candidates are required to sign the Candidate Release Form (see "Exhibit B"). This form will be distributed during registration on your assigned exam day. All candidates and patients (primary and backups) that will be treated during the examination are required to sign the Patient Release Form (see "Exhibit C"). **These forms must be submitted to Sonya Napier at [snapier@augusta.edu](mailto:snapier@augusta.edu) prior to the examination.** However, copies of these forms will be available in the clinic during testing if needed.

### **PATIENTS**

It is the responsibility of each non-DCG student candidate to provide their own patients and it is recommended that each non-DCG student candidate secure backup patients. **The Dental College of Georgia does not allow non-DCG student candidates access to the College's patient records (this includes active patients assigned to the College's students).** The Dental College of

Georgia cannot provide patients for non-DCG student candidates. Please do not ask anyone at the College for patients or patient records.

- The board requires that non-DCG student candidates make arrangements for their patients to receive follow-up care if treatment during the examination is unsatisfactory.
- Treatment of patients in the Dental College of Georgia at Augusta University is restricted to academically registered students only (except on the days of the CDCA-WREB-CITA/ADEX examination). Augusta University employees will be present to dispense supplies and materials during the examination.
- Candidates are responsible for supplying their own chairside assistant if taking a patient-based exam.
- As directed by CDCA-WREB-CITA, candidates and their assistants must strictly adhere to all CDC guidelines concerning barrier protection and instrument/equipment sterilization. Sterilization, Instrument Collection, and Dispensary facilities will be available from 7:00 a.m. until 5:30 p.m. on the days of the examination. These facilities are located near the clinical area.
- Children are prohibited in the clinic area. There are no facilities for children; please inform patients that children may not be left unattended in the waiting area. Please instruct patients to leave their children at home or arrange to have a responsible adult available to supervise them at all times.
- **Masks are required in the building at all times.** All non-DCG student candidates and those accompanying the non-DCG student candidates will be required to wear a mask. Masks will not be provided by the Dental College of Georgia but by the non-DCG student candidates.
- All persons entering the buildings will be screened for COVID-19. Non-DCG student candidates are encouraged to screen their assistants, patients and anyone else accompanying the non-DCG student candidates, assistants and patients 48 hours prior to the exam. **Depending on the answers to the COVID-19 questions and/or temperature reading, entrance into the building may be denied based on the results of the screening.**

#### **SUPPLIES AND EQUIPMENT**

- Non-DCG student candidates are responsible for providing their own **instruments, burs, Endo files, cavitron handpiece handle, 30K cavitron inserts, and handpieces** for the examination. However, if necessary, the Dental College of Georgia offers several instrument rental packages. If you wish to rent instruments, prior arrangements must be made.
- Non-DCG student candidates interested in renting instruments from the Dental College of Georgia for use during the examination should refer to the following attachments:

- ***Non-DCG student candidates are also responsible for providing their own personal protective equipment (PPE) that is in compliance with current CDC and DPH regulations. This includes disposable gowns, gloves, masks, face shields, head coverings, and shoe coverings for non-DCG student candidates, assistants and patients, and anyone else accompanying the non-DCG student candidates, assistants and patients. If the transmission level of COVID-19 is high in the community, N95 respirators and face shields are expected for both non-DCG student candidates and assistants during aerosol generating procedures. The Dental College of Georgia expects each non-DCG student candidate and assistant to have been fit-tested in conjunction with a respiratory protection program in compliance with OSHA before the testing date.***
- The Dental College of Georgia furnishes candidates with most clinical supplies/materials needed during the examination. The Dental College of Georgia does not have a school store nor is there a dental supply company on-site for those needing to purchase instruments, materials or equipment. As such, non-DCG student candidates should plan accordingly. To view a list of clinical supplies/materials that are provided to candidates, see “Materials Provided by The Dental College of Georgia for the CDCA-WREB-CITA/ADEX Board Examination” in the attachment.
- Handpieces and all instruments must be supplied by the non-DCG student candidate (unless rented). If you intend to use fiber optics, then you must have a handpiece that fits a 4-hole I.S.O. coupling. **If you intend to use an electric handpiece, then you must use a Bien Air handpiece. No other electric handpieces can be used with DCG equipment.** Dental operatories are equipped with DENTSPLY 30K cavitrons. If you have questions concerning DCG equipment, please contact Nekesha Lattimore at [nelattimore@augusta.edu](mailto:nelattimore@augusta.edu) or 706-721-6180. Do not bring KAVO handpieces. Only handpieces that connect to a standard 4-hole I.S.O. coupling will work with DCG equipment.
- **CDCA-WREB-CITA will provide an Acidental typodont to candidates taking the manikin exam.** The Acidental typodonts will be mounted on ADEC simulators in the Thomas P. Hinman Simulation Lab for the Prosth/Endo exams and the Rest/Perio manikin exams. All simulation units can be adjusted to accommodate left-handed operators. Facial shrouds will be provided to all exam candidates by the Dental College of Georgia.
- Once the examination begins, the examination areas are secured overnight. However, it is recommended that you remove your equipment at the end of the day. If you choose to leave your equipment in your assigned operator, neither CDCA-WREB-CITA nor the Dental College of Georgia will be liable for any items lost or stolen.
- No equipment or items can be left in the Sim Lab overnight. All equipment must be removed at the end of the examination.
- **If you experience any difficulty with equipment during the examination, DO NOT attempt to make repairs.** Qualified equipment technicians will be available in the clinic/Sim Lab. Inform the clinic assistant/dispensing clerk of any equipment problems.

## **RADIOGRAPHS**

The Dental College of Georgia only uses printed radiographs for this dental licensure examination. No capability for viewing digital radiographs will be available in the clinic

operatories. **All digital radiographs must be printed before coming to the exam site.** We cannot print radiographs from a thumb drive (bring them printed). Any radiographs made **during** the examination will be printed by clinic personnel. If a non-DCG student candidate chooses to use traditional mounted radiographs/conventional film, a limited number of view boxes will be available at the Dispensary window adjacent to the clinical area. Therefore, all non-DCG student candidates are encouraged to bring printed radiographs. Failure to follow this policy may negatively impact your clinical examination time.

### **ACCESS TO FACILITIES**

- Manikin examinations will be given in the Thomas P. Hinman Simulation Lab (Sim Lab) located on the 3<sup>rd</sup> floor in the Dental College of Georgia (see attached map).
- Patient examinations will be given in a designated clinic (location TBD) in the Dental College of Georgia.
- The building will open at 6:00 a.m. unless otherwise requested by the testing agency.
- Registration for the manikin exams will be held in the Sim Lab at 6:30 a.m.
- Registration for the patient exams will be held at 6:30 a.m. (location TBD).
- Access to the clinical area will begin at 7:00 a.m. on the day of the examination.
- Candidates taking the manikin exam should enter the Dental College of Georgia through the front entrance and take the elevators to the 3rd floor where the examination will be given.
- Candidates taking the patient exam should enter the Dental College of Georgia through the front entrance and take the elevators to the designated floor where the examination will be given.
- The address for the Dental College of Georgia at Augusta University is 1430 John Wesley Gilbert Drive, Augusta, Georgia 30912 (see attached map).
- Visitor parking is available in the lot across the street from the Dental College adjacent to R. A. Dent Blvd (see attached map). When entering the parking lot, visitors will press a button to receive a ticket and the gate will open allowing entry to the lot. Front desk staff will validate tickets upon arrival at the school, or the Site Coordinator will arrange to have these tickets validated. **The gate will be open the weekend of the examination, so parking tickets will not be issued on Saturday and Sunday.**
- Food service is not available, but vending machines are located on the 1st, 3rd, and 4th floors of the Dental College of Georgia.

### **STERILIZATION**

- Non-DCG student candidates are responsible for providing their own **instruments, burs, Endo files, cavitron handpiece handle, 30K cavitron inserts, and handpieces** for the examination (unless rented from the Dental College of Georgia). Every effort will be made to sterilize the instruments in a timely manner.

- **Manikin Exams:** Non-DCG student candidates who rent instruments from the DCG will have their instruments placed at their simulation units on their assigned day. Candidates must return all rented instruments to the Sim Lab Dispensary (Room GC-3060) that is across the hall from the 3<sup>rd</sup> floor Simulation Lab. The dispensary staff will check the items out to the candidates and back in when they are finished.
- **Patient Exams:** Autoclave bags, autoclave tape, and marking pens will be available and set up outside the Instrument Collection Area adjacent to the clinical area. The Central Sterilization staff will autoclave the candidate's bagged and labeled instruments. Please allow a minimum of one hour for processing, which means bagged instruments must be turned in at least one hour before closing time to ensure sterile instruments for the next morning. Sterilized instruments can be picked up at the Dispensary window adjacent to the clinical area on their assigned day.
- **Non-DCG student candidates that need to have their personal items sterilized for the exam will need to have those items to Sterilization BEFORE 5:00 p.m. the day before the exam.** Non-DCG student candidates are not required to have their items sterilized by the DCG. However, if an examiner finds an issue with the candidate's instrument packaging or questions the sterility of an item they brought with them, it will be on the candidate and not the dental school. Non-DCG student candidates can contact Wendy Miller, Central Sterilization Manager, at [wemiller@augusta.edu](mailto:wemiller@augusta.edu) or 706-721-7986 (office), 706-306-0142 (mobile) or 706-721-3958 (Main Sterilization) to arrange a time to drop their items off to be sterilized for the boards. Ms. Miller will arrange to meet candidates inside the front entrance to the school. All items must be clearly marked with the candidate's information so that it is all kept together. Candidates taking the manikin exam can pick up their personal items from the Sim Lab Dispensary window (Room GC-3060) across from the 3<sup>rd</sup> floor Sim Lab on their assigned day. Candidates taking the patient exam can pick up their personal items from the dispensary window adjacent to the clinical area on their assigned day.

#### **MEDICAL EMERGENCY PROCEDURES**

1. Recognize that an emergency exists
2. Call for help
3. Begin emergency care
4. Notify the attending clinician, clinical staff, or dispensing clerk

#### **Clinical Staff or Dispensing Clerk will then:**

1. Send an individual to retrieve the emergency cart
2. Give appropriate emergency care
3. Instruct another individual to call the AU Police Department at 706-721-2911 if an ambulance is needed. The AU Police Department will contact the 911 operator.
4. Send two other individuals to the front AND back of the building to direct the ambulance.
5. Maintain a log of events.

## ATTACHMENTS

### Policy for Instrument Rental

Instruments are available for rent. The cost is the same for renting one or more instruments.

#### **Dental (all parts of the exam):**

- Includes handpieces and instrumentation
- **\$6,000 Total Charge** - will be charged to MasterCard, Visa, Discover or American Express
- \$1,000 Non-refundable rental fee
- \$5,000 Security deposit - will be credited back to credit card after instruments have been returned and checked in to the 3rd floor Sim Lab Dispensary (manikin exam) and the Collection Room (patient exam) adjacent to the clinical area

#### **Dental (Either Endo/Pros OR Rest/Perio):**

- Includes handpieces and instrumentation
- **\$3,000 Total Charge** - will be charged to MasterCard, Visa, Discover or American Express
- \$500 Non-refundable rental fee
- \$2,500 Security deposit - will be credited back to credit card after instruments have been returned and checked in to the 3rd floor Sim Lab Dispensary (manikin exam) and the Collection Room (patient exam) adjacent to the clinical area

#### **Dental (handpieces only):**

- **\$1,500 Total Charge** – will be charge to MasterCard, Visa, Discover or American Express
- \$350 Non-refundable rental fee
- \$1,150 Security deposit – will be credited back to credit card after handpieces/motor have been returned and checked in to the 3rd floor Sim Lab Dispensary (manikin exam) and the Collection Room (patient exam) adjacent to the clinical area

**Candidates must contact the DCG Business Office no later than 3:00 p.m. the Monday prior to the Board Examination.** We are not able to accept online payments or checks for instrument rental fees. Therefore, these fees must be paid by phone with a credit card (MasterCard, Visa, Discover or American Express). The candidate's credit card will be charged the total amount (e.g., \$6,000, \$3,000 or \$1,500). The candidate's instruments will be available at their station in the 3<sup>rd</sup> floor Sim Lab or their operatory in the clinic on their assigned day. The candidate will return instruments to the 3rd floor Sim Lab Dispensary where an inspection of the instruments will be made. If all instruments are returned and are undamaged, the Sim Lab Dispensary staff will give the candidate a statement indicating that their credit card will be credited the refundable amount (i.e., security deposit). The cost for any missing or damaged instruments will be deducted from the refundable amount. The refund will be applied to the candidate's credit card by Tuesday following the Board Examination. **Candidates may call the DCG Business Office at 706-721-6832 to make a payment by phone.**

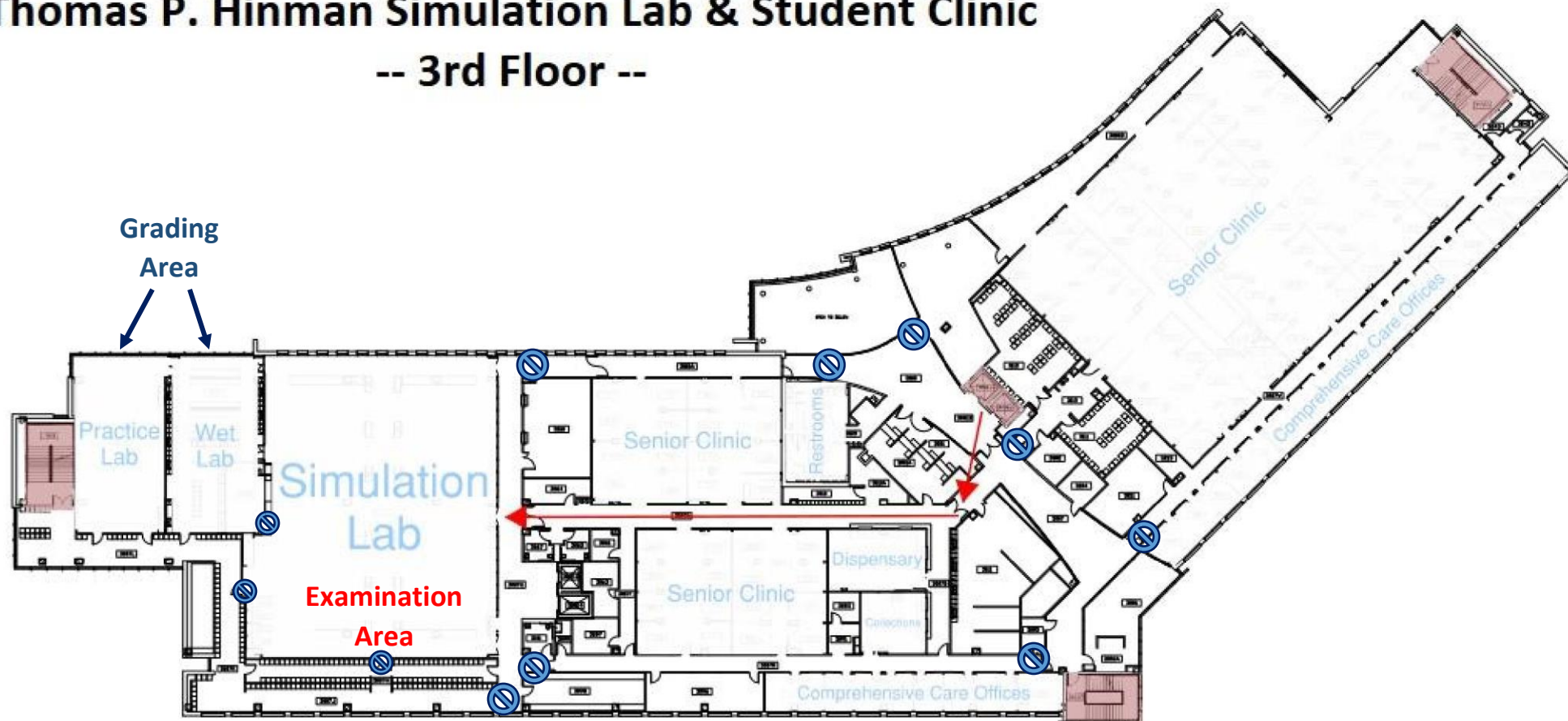

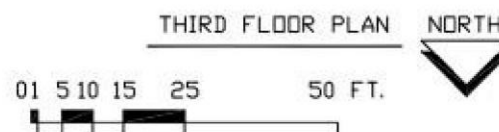

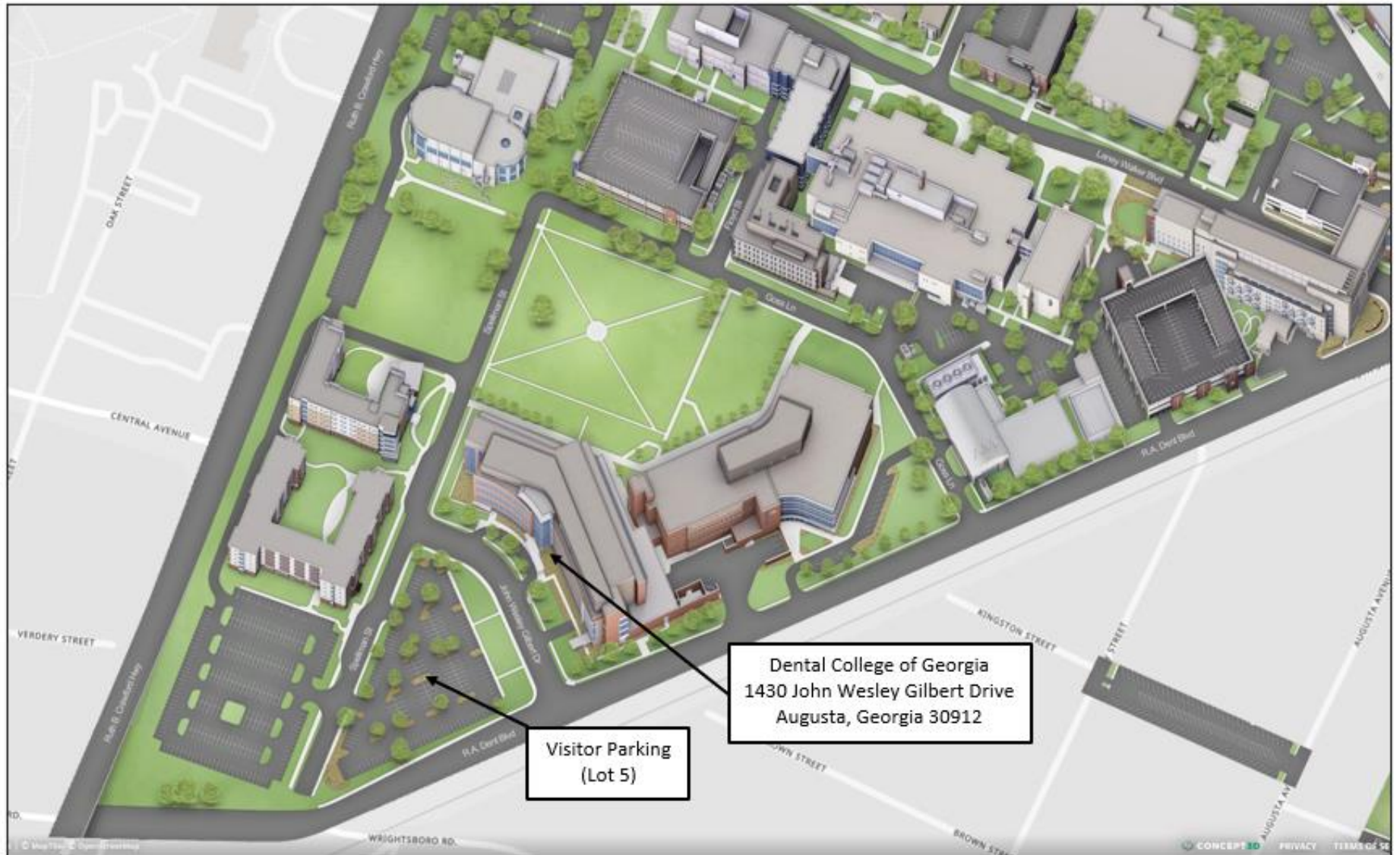
