Hygiene Candidates:

It is important that you understand your responsibilities as a CDCA-WREB-CITA hygiene candidate at this site. Review the following material thoroughly. Cubicle assignments for Hygiene candidates will be posted the evening before the examination in the Lower Lever Clinic (press B on the elevator) of the dental building.

Facility Fee:

All non – Howard University dental student candidates participating in the Commission on Competencies Assessments at this site are assessed a \$250.00 facility fee. This is to be paid in Cash. An ATM is available in the lobby of Howard University Hospital or the Barnes and Noble Howard University bookstore across the street on Georgia Avenue. In addition to the facility fee, a check for \$250.00 is required as a refundable security. All fees must be paid in room 326 in the College of Dentistry prior to the beginning of the exam. This fee includes all consumable products such as gloves, mask, saliva ejectors, prophylaxis paste, disposable prophylaxis angles, dental floss, gauze, all barriers, and hand instruments. Candidates must furnish their own hand pieces, cavitrons, blood pressure cuff, stethoscope, and clinician and patient protective eye wear. The College of Dentistry does NOT have handpieces, cavitrons, curing lights or amalgam triturators. It is the responsibility of the candidate to disinfect his/her unit before and after the exam.

Payment of this fee does not entitle the outside candidates to use the school to practice or to screen for patients.

Orientation:

Orientation for the Dental Hygiene Exam is now offered online only

Parking:

There is limited street parking. However, there is parking lot at the hospital (~\$15.00 per day) and there is a parking lot next to the McDonald's on Georgia Avenue (~\$10.00 per day).

COVID:

Handpieces:

Candidates should furnish their own handpieces, instruments and Cavitrons when possible. The candidates are responsible for providing their own Mid-West style 2- or 4-hole hand piece. All equipment is dispensed by signature and must be returned to the dispensing clerk immediately at the conclusion of the examination.
