

## 2023 CDCA-WREB-CITA Dental Hygiene Simulated Clinical Examination at Illinois Central College Information Sheet

Illinois Central College will serve as a testing site for this non patient clinical examination and requires a \$75.00 site fee to help defray the cost of materials and supplies and equipment used during the examination.

Handpieces are available for those needing them once the \$75.00 site fee and a \$200.00 security deposit are received. The security deposit of \$200.00 will be returned when the handpiece is returned in its original working condition.

This fee(s) must be received two weeks prior to the examination. Payment must be sent in the form of **a check, a cashier's check, or money order made out to SADHA**. If the candidate does not wish to use the available handpiece, one check for the \$75.00 site fee is required.

**Credit/debit cards are not accepted.**

The ICC Dental Hygiene Clinic has A-dec dental chairs and the delivery system is over the patient.

This fee entitles each candidate to the following items:

- paper towels
- disposable instrument tray
- light handle barriers
- patient napkin/drape
- saliva ejector
- disinfecting solution
- polishing agents
- prophy cups and brushes
- handpiece with disposable prophy head (\$200 security deposit required)
- gauze, cotton swabs
- disclosing agents
- floss and/or dental tape
- gloves
- 1 mask (Level III – Not N95)
- 1 Disposable Face Shield
- 1 gown
- autoclave bags and tape
- cavitron ultrasonic transducer (30K); **bring insert tip**

Candidates will **not** be provided with any hand instruments.

Please note that the dental hygiene clinic, and therefore the testing site, is **not** on the main ICC campus in East Peoria. 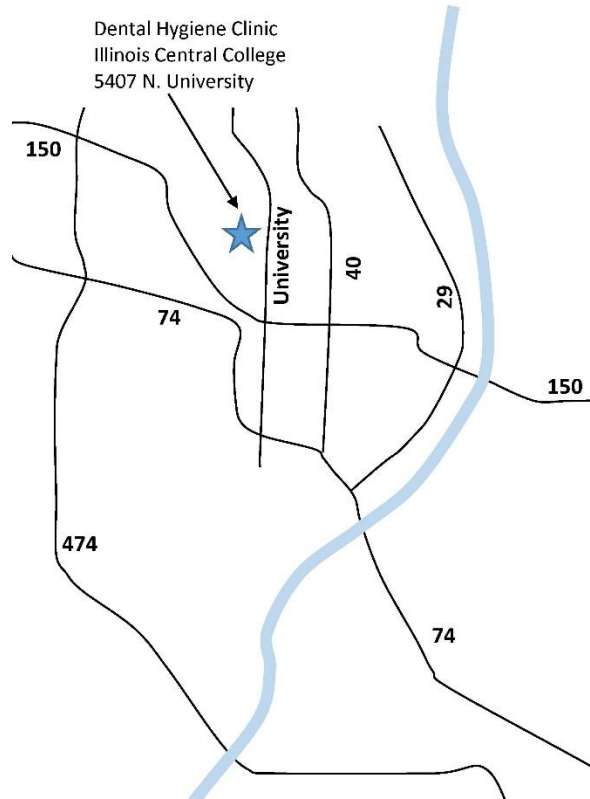
