Dental Candidate Information Sheet

Nova Southeastern University College of Dental Medicine is pleased to allow the use of its facilities for the CDCA-WREB-CITA/ADEX Dental Examination. This handout is intended to address questions regarding the facilities at our college. Facilities Fee: The facility fee is \$600.00 for candidates who are not students of Nova Southeastern University and will be collected by CDCA-WREB-CITA during online candidate registration. The facility fee covers facility usage and expendable items, a list of which can be found at the end of this document.

Equipment: The candidate must furnish all instruments and supplies considered necessary and appropriate to complete the treatment assigned by the Board. This includes all high and low-speed handpieces and the necessary adapters. The College uses a-dec 6-hole hoses and Bien-Air electric handpieces – see attached handpiece hose connection diagrams.

Candidates may bring their own Cavitron and tips. – See photos at the end of document.
(No cavitron will be used in this exam series)

Equipment rental and fees: There are no instruments available for rental.

Air/Water Syringe Tips: The College will supply disposable syringe tips.

Supply and Equipment Purchase: Henry Schein, Inc. maintains a dental store on the third floor of the Dental building. They are available for purchase of all necessary items. However, it is urged that you contact them a few weeks prior to your exam at [\(954\) 262-7356](tel:9542627356) to ensure that your needs are met and that all items are purchased in advance. The store hours are Monday thru Friday from 8:15am – 4:45pm.

Patient Procurement: The College of Dental Medicine will **not** furnish any patients nor provide clinic records of any patients for either screening or use during the examination. You are strongly advised to bring your own patients with you. There are other alternatives, such as personal contacts, private practitioners in the area, etc. that you can explore on your own. **(No patients in this exam series)**

Patient Screening: The College of Dental Medicine will not be able to furnish any screening facilities. **(No patients in this exam series)**

Radiographs: Radiographs will not be provided for candidates.

Release Forms: All candidates must have a release form signed by each individual patient. These forms will be available on-site. **(No patients in this exam series)**

Manikin Exam: CDCA provides candidates with mounting plates, shrouds and typodonts. Prior to taking the manikin exam, please click on the link <https://youtu.be/j2lAtykOwKQ> to view the *Sim Lab Instructional Video*.

Dental Unit Malfunctions: There will be someone from engineering on the clinic floor and simulation laboratory if needed for repairs of all operatories at all times.

INFECTION CONTROL

Universal Precautions/Standard Precautions: The College of Dental Medicine practices Standard Precautions (gloves, face masks, eyewear, and protective clothing) during all patient encounters. The College will provide gloves and face masks, but candidates will be responsible for providing their own OSHA acceptable eyewear for both themselves and their patient(s). **(No patients in this exam series)**

Clinic Attire: The candidates will provide their own clinic attire that meets OSHA standards. Overgowns will be provided by the candidate. They may not be worn outside the treatment area or from one clinic to another.

Surface Disinfection: All candidates are to use a modified spray-wipe technique for surface disinfection of the clinic operatory (patient chair, stools, light handles, counter tops, etc.) The following materials are available to maintain OSHA standards:

- Amalgam scrap containers (in panoramic X-ray room on the floor) Cavicide surface disinfectant
- Headrest cover for dental chair
- Plastic adhesive barriers for light handles red bags for disposal of contaminated items
- Sharps container for disposal of needles and empty anesthetic carpules Pharmaceutical waste container for disposal of anesthetic carpules with medication

Sterilization: Sterilization will be available during the exam process for NSU-CDM students only. All instruments that candidates provide for themselves must be sterilized in accordance with CDC and OSAP standard practices.

In case of emergency, including but not limited to needle stick exposures, the candidate and/or Board Examiner will determine whether Emergency Service (911) and NSU Public Safety is to be called at (954) 262-8999. The candidate should have proof of their health insurance coverage for these circumstances.

EXPENDABLE MATERIALS LIST

The following is a list of expendable materials that will be supplied in sufficient quantities for all candidates:

Articulating paper
Wedges
Sectional matrix (for garrison system)
Filtek Supreme composite
OptiBond FL
Liner – Dycal, Fuji
Cotton – rolls and 2x2 gauze
Cotton tip applicators
Prophy paste
Evacuation and saliva ejector tips
Napkins and facial tissue
Non-Latex Rubber Dam
Floss, unwaxed
Gloves, examination type (non-latex)
Tongue blades
Headrest and chair covers

- NSU/CDM provides latex free gloves only.
- Dispensing Area will be open for all necessary dental materials for patient-based examination (Restorative and Periodontal). **(No patients in this exam series)**
- All expendable material will be provided for Manikin-based examination.
 - You will need to bring your own files, gutta percha and sealer.

ADDITIONAL INFORMATION

Maps and Directions: Our dental clinic address is **3200 S. University Drive, Davie, FL 33328** and corresponds with 19F on the map below. Please make yourself familiar with the location prior to exam day.

Parking: Parking is available in a five-story parking garage adjacent to the dental school and corresponds with 19H on the map. Limited parking is also available just east of the school.
