This letter provides site information for Non-University of Minnesota School of Dentistry students about the CDCA-WREB-CITA DDS and DT licensure examinations at the University of Minnesota School of Dentistry. Please read this material carefully as all of the information is important.

The School of Dentistry's Dental Clinic is located at 515 Delaware Street SE, Minneapolis, MN 55455 in the Moos Health Science Tower (Moos HST) on the East Bank of the Minneapolis Campus. If you are driving, the closest parking ramp is the Washington Avenue Ramp and is conveniently connected to our building. Moos Tower is the second most frequent stop on the City bus line and is the East Bank stop on the Green Line metro train. A Q & A session with the Chief Examiner will be hosted the evening prior to the exam event. Additional details will be sent to all registered candidates via email.

School of Dentistry Facility Fee and Instrument Kit Rental

The facility fee for this exam is \$600.00, which also includes the rental of instruments, handpieces, and use of all dental materials needed for the exam. Even if you choose to bring your own instruments/materials, you are still responsible for the facility fee, as this covers the school's costs to administer the exam. The instrument rental included in the facility fee is offered as a courtesy to the candidates rather than charging a separate instrument rental fee. The facility fee will be collected by CDCA-WREB-CITA during online registration.

We will provide you with a complete set of sterile instruments, including handpieces for each patient, as listed starting on page 5. You will also have the use of an ultrasonic scaler* and tips for the periodontal portion of the patient based examination; a light curing unit is provided for composite restorations.

*Ultrasonic scalers are not available for manikin based examinations.

If you choose to bring your own instruments and hand pieces for the examination, your instruments and handpieces must be sterile before patient use and need to be in appropriate packaging. **Sterilization services are not available prior to the examination.** The site will provide you with sterilization pouches for your contaminated instruments. Please Note: Our dental units only accept a certain type of disposable air/water syringe tip. We will provide them for you.

Air pressure in our operatories is regulated for Brasseler hand pieces at 40 psr. They are equipped with six pin swivel connectors for high speed and five pin connectors for low speed handpieces.

Personal Protection and Infection Control

It is the policy of the School of Dentistry Clinics that all personnel wear protective glasses with side shields, over-garments, gloves and facemask while performing intraoral exams or providing treatment. This applies to dental assistants, dental hygienists, dental therapists, and dentists. **Each candidate and dental assistant is responsible for providing their own protective eyewear;** over-garments, gloves and masks will be furnished as part of the basic site fee.

Cubicle surfaces and operatory equipment must be cleaned and disinfected with the supplied disinfectant after patients are dismissed. Instruments are to be returned in the same condition you received them. As was mentioned earlier in this letter, if you are providing your own instruments, you must bring them in sterile condition. After the exam, we will provide you with pouches for your contaminated items.

Manikin-based Exams

The School of Dentistry only provides the manikin. Accidental typodont, modules and teeth as required by CDCA-WREB-CITA are provided by CDCA-WREB-CITA. Manikin-based exams will be held on the 4th floor of Moos HST.

Patient-based Exams

For liability reasons, **we are unable to provide candidates with U of MN Dental School patients.** We **do not** have a patient pool of non-University patients for you to draw from. Also, **you will not be allowed to screen patients at the School of Dentistry.** Therefore, you must provide your own patients. Patient-based exams will be held on the 9th floor of Moos HST.

You will not be able to take Radiographs.

In the event you are unable to successfully complete a patient procedures, it will be necessary to make arrangements for completion. In all cases, mutually satisfactory arrangements for treatment and fees will be agreed upon before your records are cleared by CDCA at final checkout.

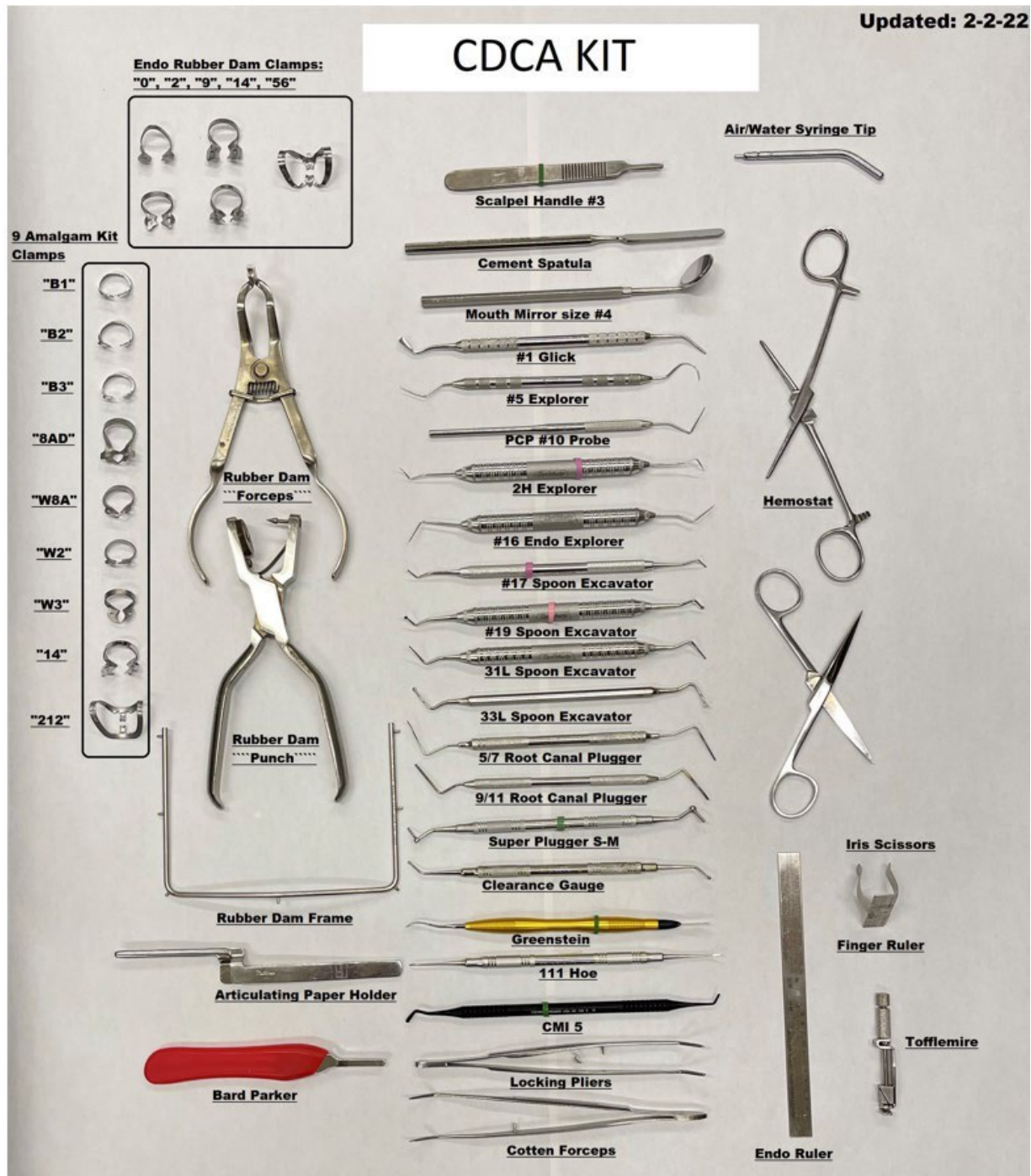

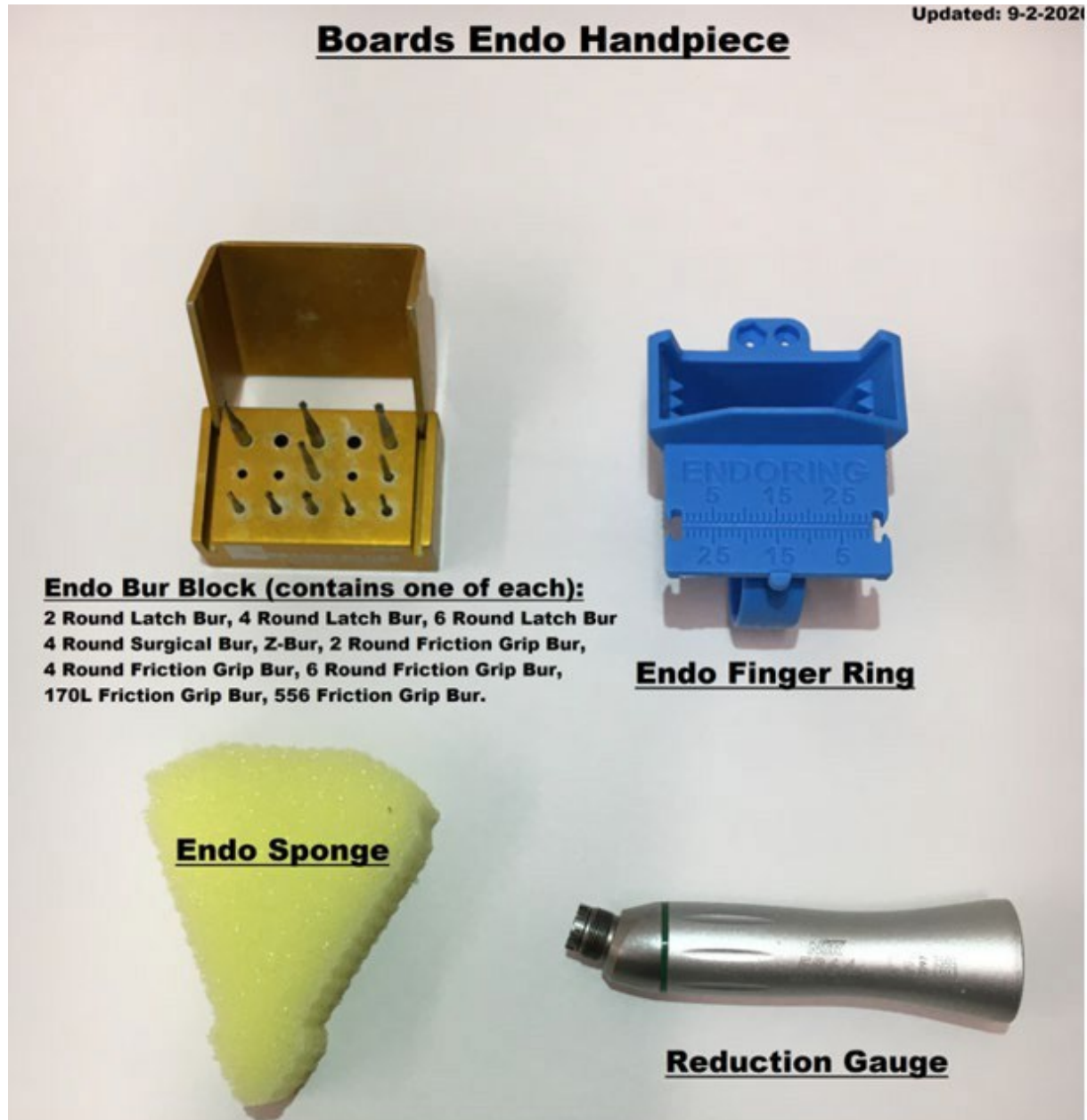
